- screening GC/MS, HS-GC/MS and SPME-GC/MS of the products have not detected any substances potentially dangerous to human health.
- sensory analysis tests according to UNI EN 1230-1:2009 and UNI EN 1230-2:2009 confirm compliance
  of the products with Article 3 of Regulation (EC) No 1935/2004 and amendments.
